# Women's Aid responds to the prime minister's announcement on future funding for refuges

On 13<sup>th</sup> May, the prime minister announced future of funding for refuges, setting out proposals to place a new legal duty on local authorities to provide support in 'secure accommodation' for survivors of domestic abuse and their children, creating a new statutory system for the funding of refuges and other services within the community.

This new statutory duty on local authorities will have four parts:

- A duty on 'upper-tier' local authorities to convene a multi-agency partnership, which will have to undertake needs assessments of survivors in their area, oversee the provision of support in accommodation-based services to meet these needs, and develop and publish a local strategy to deliver this support.
- A requirement on 'lower-tier' local authorities to cooperate with the upper tier.
- A requirement on local authorities to monitor and assess the provision of support, and report back to government.
- A duty on the secretary of state to provide statutory guidance that will underpin this new funding model.



- Eligibility: Fathers who have physically/ emotionally abused or neglected their children and/or exposed them to woman abuse
- Focus is on fathers' accountability for abuse, countering the attitudes linked to abusive and neglectful behaviors and on promoting healthy relationships between fathers and their child and child's mother
- Men's motivation is specifically addressed
- Service is coordinated in partnership with child protection

## Vacancies at Cambridge Women's Aid

Full time Family Support Worker to work with children and their mothers/carers affected by domestic abuse

You will be a key person in the team of workers providing CWA's coordinated family support service. In addition, you will help to develop and improve our expanding service. You must hold a relevant level 3 qualification in childcare, education, health, social work or teaching and have experience of supporting vulnerable families.

This post is fixed term for a minimum of two years. It is based in Cambridge City with some travel across the county and is paid at the new NJC pay scale 24 which is £27,905 p.a for a 37 hour week. In addition there is a 5% pension contribution.

**Part time Children's Worker** wanted to work to provide daily one to one and group sessions to children living in the Cambridge refuge.

You will have experience of looking after children and planning activities to meet their needs. You must hold a relevant level 2 or 3 qualification in childcare, education, health, social work or teaching. Experience of supporting vulnerable families is an advantage.

This post is fixed term for a minimum of two years. It is based in Cambridge City with some local travel. It is paid at the new NJC pay scale 16 - 18 which equates to  $\pounds 18,947 - \pounds 19,713$  p.a for a 30 hour week. In addition there is a 5% pension contribution.

Closing date for applications for both posts is midday on Friday 24<sup>th</sup> May 2019 Interviews will be held in the week commencing 3<sup>rd</sup> June

CWA is committed to quality, equality and valuing diversity. We would like to encourage applications from people from minoritised and racialised communities, people under-represented in similar roles and people without university degrees, who have the skills described in the person specifications for the roles. Women only need apply under schedule 9 (Part 1) of the Equality Act 2010.

## The Dynamics of Domestic Abuse and Drug and Alcohol Dependency

This article draws interpretively on in-depth qualitative interviews with male perpetrators and their current and former partners. These interviews were undertaken for the National Institute for Health Research-funded ADVANCE programme. The article's analysis highlights the diverse ways in which domestic abuse by substance-using male partners is compounded for women who have never been substance dependent, women who have formerly been substance dependent and women who are currently substance dependent.
