Hello and welcome to our August newsletter.

Earlier in the year we were writing about when things return to 'normal' but we now seem to be stuck in Groundhog Day with little change happening in the work week by week. We hope you are staying safe and well and will be able to take some time off over the Summer.

The Domestic Abuse Bill will be returning to the Lords after Summer Recess but the draft guidance has been published. We are pleased to see a new clause which outlaws the so-called 'rough sex' defence,, and an amendment so children affected by domestic abuse will be recognised as victims in their own right. However, there are still significant gaps around migrant women, especially those with no recourse to public funds.

NHS finds more than 200 cases of female genital mutilation on UK-born women and girls in one year

Despite being illegal in the UK for over 30 years, more than 200 cases of female genital mutilation (FGM) performed on women and girls born in the UK were identified by NHS staff during one year, figures show.

Some 6,590 women and girls had a procedure to treat their FGM or were identified as having experienced FGM previously when they were treated between April 2019 and March 2020. Of these, 205 were women or girls who had been born in the UK, according to an annual report from NHS Digital.

Since the data started being collected five years ago, around 24,420 women and girls have been identified as having previously been subject to the practice.

For Baby's Sake evaluation

The Stefanou Foundation was established by philanthropist Stelio Stefanou with the aim of tackling the root causes of cycles of disadvantage and vulnerability affecting those without a voice. Scientific evidence about the impact of domestic abuse and trauma on babies led the Foundation to create **For Baby's Sake** as an innovative intervention to break the cycle of domestic abuse and give babies the best possible start in life.

The Foundation and researchers at Kings College, and including academics from University of Warwick, University of Central Lancashire, University of Cambridge and McMaster University, Canada have published this report that focuses on this work. The academic evaluation team have identified For Baby's Sake as the first programme of its kind to 'fill an important gap in provision' through its 'unique approach', working with the whole family and starting in pregnancy.

New extended Live Chat service from Cambridge Women's Aid

Cambridge Women's Aid has extended its Live Chat service - a free, confidential advice and emotional support service for women in Cambridge, South Cambs and East Cambs who have experienced domestic abuse at any point in their life, or who are worried about a relationship.

Every Wednesday 3pm-5pm, and **Friday 11am-12pm**, women can chat online to a highly trained support worker at Cambridge Women's Aid. Our workers are experienced in supporting survivors at their own pace, and creating a safe space to explore feelings and options, as well as providing advice, information, signposting and referrals into the service for ongoing support.

The Live Chat service will help make it easier for women to access support in a safe and discreet way during the Covid-19 lockdown.

Project update from One Voice for Travellers

One Voice for Travellers have been running employment workshops for women and girls who are survivors of domestic violence, abuse, and control, living in East Cambridgeshire and Fenland. The workshops are designed so that the women and girls can develop skills and obtain knowledge and thus confidence in the process of applying for employment.

During COVID the sessions have been running in several ways - by closed Facebook groups, one to one work on phones (with work being sent out by post and including a stamp address envelope for return) and E-mails. As COVID restrictions start to lift they are starting once again to include face to face (giving due regard to social distancing etc)

The work is undertaken in groups or one to one, in a format, time and if needed a venue of choice by those taking part. A warm and friendly welcomes all. Literacy and/or numeracy is no barrier.

Job Vacancy – Commissioning Support Officer

A vacancy has arisen for a new post in the Office of the Police and Crime Commissioner supporting the management of grants and contracts awarded to public, private and third sector organisations.

The successful candidate needs to be organised and efficient with a keen eye for detail? Knowledge of public sector commissioning, contract management or procurement processes is also important. While the focus will be on organising and supporting contract monitoring meetings with services supporting victims of crime, the postholder will also be involved in a range of other contracts and grants held by the Commissioner.

The role will be varied: the successful candidate could be helping with a bid for extra funding to support domestic abuse survivors one week and designing new services for victims of modern day slavery the next. However, they do need to be comfortable interpreting large volumes of data and completing complex returns to the Ministry of Justice or Home Office. They also need to be smart, professional and engaging and used to developing positive working relationships with local stakeholders.

Drug Alert

Public Health England issued a national alert on the 24th July, 2020, in relation to the availability of, and harm from, illicit drugs sold as **benzodiazepines** particularly when used in conjunction with alcohol and drugs with a respiratory depressant effect including gabapentinoids and opioids.

There is significant evidence from toxicology results of illicit tablets being sold as **diazepam**, **temazepam** and **alprazolam** linked to recent hospitalisations and deaths, and from police seizures, that some illicit drugs sold as benzodiazepines are causing harm. This includes tablets known as and/or marked with 'DAN 5620' (on one side) and '10' (on the other), 'T-20', 'TEM 20', 'Bensedin' and 'MSJ' which may contain dangerously potent benzodiazepines or their analogues such as **flubromazolam**, **flualprazolam** and **etizolam**. Most of the tablets causing concern are blue (but they come in various colours) and these may stain people's mouths

Dependent opioid users; and teenagers and young adults appear to be increasingly using illicit benzodiazepines and therefore at particular risk. There is an increased possibility of overdose arising from these illicit drugs sold as benzodiazepines

Harm reduction advice

□ Avoid buying or using tablets sold as benzodiazepines, most often diazepam (often referred to as 'Valium'), temazepam and alprazolam (often referred to as 'Xanax').
□ Don't use any combination of benzodiazepines, opioids such as heroin and gabapentinoids such as gabapentin and pregabalin, with or without alcohol.
\Box If you're going to use any drugs, make sure someone is around when you take them (if you overdose alone nobody can help you)
\square Be extra cautious about the sources from which you get your drugs, and about the drugs you take, test the dose by starting with a small test dose (1/2 a pill) and waiting at least an hour before taking more
\Box seek treatment for your drug use if it is causing you problems and you are not already in treatment

Support for sudden bereavement

Sudden is a free service for bereaved people protecting their emotional and physical wellbeing from day one, and for the first ten weeks, at a time of shock and loss in cases when someone has died suddenly or too soon.

We are here for people bereaved by:

- COVID-19, or any other medical reason that happened suddenly or ended a life too soon;
- an event / incident of any kind that caused fatal injury
- suicide

Sudden is part-funded by the Department of Health and Social Care. It is a crisis response to COVID-19 but is here for the long term. It is receiving very positive feedback from users, and is run by a professional sudden bereavement team, within an established charity (Brake, which operates the National Road Victim Service for road crash victims).

The Sudden service fills a 'care gap'. (Grief support services, such as counselling, are appropriate later.)

The Sudden service provides:

- emotional support from day one, onwards, by phone or email, from a trained, named worker, at agreed times
- safeguarding, and continual assessment of a bereaved person's health, safety, and any acute needs
- a pathway towards wellbeing goals, with goals agreed with the bereaved person and unmet goals addressed
- help, advocacy, and referrals to meet care needs; emotional, practical, procedural, financial, and health
- mental health 'active monitoring'; and clinical escalation, including signposting to mental health services
- safe exit at around 10 weeks, including signposting to grief support, and other services, relevant at that time
